## Effective Date of OMH COVID-19 Disaster Emergency Telemental Health and Program Guidance

Issued: April 20, 2020

The effective date for COVID-19-related disaster emergency relief issued by the New York State Office of Mental Health is March 7, 2020, the date of New York State's declaration of a disaster emergency. All telemental health guidance and program guidance listed below may be operationalized retroactive to March 7, 2020:
