OASAS Review of the FY 2022-2023 Executive State of State and Proposed Budget

- In her State of the State Governor Hochul announced that OASAS will:
- Create a Division of Harm Reduction to develop and incorporate harm reduction principles across the OASAS system of care;
- Expand naloxone and buprenorphine access by mandating pharmacies to maintain a stock of these medications.
- Invest in fentanyl test strips, opioid overdose prevention kits, safety kits, and resources to prevent individuals from overdosing while alone.



In her State of the State Governor Hochul announced that OASAS will:

- Develop a public awareness campaign to prevent overdose deaths in public settings.
- Create and implement a medication-assisted treatment program for uninsured individuals.

And work with DOH to expand access to sterile syringes by allowing emergency departments and health departments to provide syringes to individuals who present with signs and symptoms of injection drug use.



Governor Hochul further directed OASAS to:

- Expand access to life saving medications by strengthening and modernizing outpatient addiction programs, including opioid treatment programs (OTP), by:
 - Removing the regulatory requirement that OTP "additional locations" must be in contiguous counties;
 - > **Developing guidelines** for providing mobile methadone;
 - > Retrofitting existing outpatient mobile treatment units



- Purchasing additional units to provide mobile services;
- Investing in telehealth equipment for mobile service providers to expand access across the State; and
- Providing individuals with supportive recovery housing by adopting a voluntary certification process for recovery-supportive housing that provides substance-free environments and mutual support for individuals recovery.

Aid To Localities Growth Highlights

- Human Services COLA \$33.7M
- Frontline Worker One-Time Bonus \$36.6M
- Maintains \$5M for jail-based SUD services total \$8.5M
- Minimum Wage Increase for OASAS Providers \$2.0M





OASAS FY 2022-2023 Executive Budget Aid To Localities Growth Highlights (continued)

Reinvestment of Medicaid Dollars

- Savings from transition of BH services to Medicaid Managed Care - \$37M
- Authorizes up to \$33.2M to strengthen and enhance home and community-based services (HCBS) consistent with the American Rescue Plan Act of 2021 (eFMAP).





Aid To Localities Growth highlights (continued)

New Opioid Settlement Fund - \$265.9M

Impacts on OASAS - \$69.3M

Expansion of Opioid Treatment Services - \$60M includes:



- ✓ OASAS Capital Budget
- ✓ Retrofit Existing Mobile Methadone Units (MMU) and add new MMUs
- ✓ Develop Medication Unit Partnerships

New Opioid Settlement Fund - \$265.9M

Impacts on OASAS (continued):

- Statewide Transportation Initiative \$1.0M
- Transitional Housing Initiative \$2.3M

Total Disbursements - \$191M

New Opioid Stewardship Fund - \$200.0M

OASAS impacts:

- OASAS Harm Reduction Services \$7.3M
- OASAS Medication Affordability \$5.0M
- OASAS Treatment Affordability \$3.0M





OASAS FY 2022-2023 Executive Budget Capital Growth Highlights

- Opioid Settlement Capital Account \$10M
- Increase for minor alterations/improvements to OASAS provider-operated facilities - \$1.5M
- Adds Capital staff \$0.5M
