

# Restricted Activities and Exemptions for Mental Health/Addiction Professions in OMH or OASAS Settings<sup>1</sup>

Date issued: December 2023

This table delineates the restricted activities individuals with specific credentials are able to perform in OMH or OASAS settings. For the purposes of this guidance, OMH and OASAS settings refers to any setting licensed, certified, or otherwise authorized by OMH or OASAS to provide mental health or addiction services and supports. Note that program guidance further details activities performed by specific staff. This table is limited to delineating restricted activities. Individuals with these credentials may perform activities in programs that are not shown in the table. Restricted Activities are defined as Assessment & Evaluation, Diagnosis, Psychotherapy, Assessment Based Treatment Planning (ABTP), and Treatment other than Psychotherapy. See page 14 for students.
